STORMWATER MANAGEMENT PLAN REVIEW FEES

An application review fee of \$2250 must be included with the initial SWMP submission. The total SWMP review fees will be based on the cost of the Water Board Engineer's review time and recording fees for the Stormwater Management Operations and Maintenance Agreement. SWMP review time will depend on each submittal's compliance with the Williams County Stormwater Rules and Regulations and the number of reviews to receive final approval. After each SWMP review, the applicant will be invoiced for the SWMP review time (more than the application review fee). Resubmittals should be accompanied with payment from any outstanding invoices. It is the applicant's responsibility to ensure that SWMP review comment responses, revisions, and documentation are incorporated into each resubmittal.

DE MINIMUS EFFECT REQUEST

An application review fee of \$500 must be included with the initial De Minimus Effect Request (DMER). The total DMER review fees will be based on the cost of Water Board Engineer's review time. DMER review time will depend on each submittal's compliance with the Williams County Stormwater Rules and Regulations and the number of reviews to receive final approval. After each DMER review, the applicant will be invoiced for the DMER review time (more than the application review fee). Resubmittals should be accompanied with payment from any outstanding invoices. It is the applicant's responsibility to ensure that DMER review comment responses, revisions, and documentation are incorporated into each resubmittal.
